Legal Studies / Pre-Law

The legal studies minor is designed for two groups of students: 1) those interested in pursuing law school; and 2) those who want an introductory understanding of law to supplement their college education. The minor is interdisciplinary, including courses drawn from a variety of relevant disciplines. Some of the courses emphasize the development of skills, such as strong communication and argumentation, which are critical to legal analysis. Still other courses introduce students to legal content or important political, social, or economic contexts for the legal system. The primary emphasis is on the U.S. law and legal system. Students must also complete a major in another area of interest; for pre-law students, this is consistent with recommendations from the American Bar Association; the Law School Admission Council, which administers the Law School Admission Test (LSAT); and most individual law school admissions counselors. The pre-law advisor also provides guidance to students preparing for the LSAT and applying to law school.
